WGA Vehicle Driver Agreement

This policy relates to anyone who will be driving a passenger vehicle provided by The Wyoming Geological Association (WGA) (such vehicle referred to herein as a "WGA Vehicle"). All WGA Vehicles will be used only for official WGA events or meetings. No WGA Vehicle Driver (as defined below) is authorized to drive a WGA Vehicle for personal or non-WGA purposes.

Before being authorized by WGA to drive a WGA Vehicle (such an individual referred to herein as a "WGA Vehicle Driver"), the individual is required to read and to confirm agreement with this policy by signing this WGA Vehicle Driver Agreement and provide a copy of the individual's government-issued driver's license, as well as provide any other documentation and information required by WGA.

We expect all WGA Vehicle Drivers to always exercise good judgment and always comply with all applicable laws and safety regulations. WGA Vehicle Drivers must be comfortable with driving a passenger vehicle containing passengers, and must have such driving experience on a regular basis (i.e., other than driving WGA Vehicles).

WGA Vehicle Drivers are "designated drivers," prohibited from drinking alcoholic beverages before and during the time they are driving the vehicle or transporting event participants. No WGA Vehicle Driver will operate a WGA Vehicle while under the influence of alcohol or illegal drugs. Additionally, no WGA Vehicle Driver will use prescription/over-the-counter drugs that carry the risk of impairing judgment while being responsible for the care and well-being of WGA participants. WGA Vehicle Drivers are also prohibited from using a cell phone at any time while in the vehicle unless the vehicle is safely parked.

Terms of this WGA Vehicle Driver Agreement may be amended or supplemented by requirements of WGA's insurance company and the rental car company or other organization from which the WGA Vehicle is rented. For example, WGA must adhere to a minimum age limit for WGA Vehicle Drivers. WGA Vehicle Drivers must be at least the age of 25 (with special permission, between 21 and 24 years of age) and hold a valid driver's license. Additionally, there may be maximum age limits required for WGA Vehicle Drivers by WGA's insurance company or rental car company or other organization from which the WGA Vehicle is rented. WGA Vehicle Drivers will comply with all rules and regulations of WGA's insurance company, and rental car company or other organization from which the WGA Vehicle is rented, including, without limitation, by providing any documentation or information required by any of them at any time.

An Incident Report Form must be completed and submitted to the official WGA representative as soon as possible but no later than 24 hours after the accident or incident occurs for all accidents or moving traffic violations, no matter how minor, that involve a WGA Vehicle. In addition, the WGA Vehicle Driver should promptly notify the official WGA representative if the WGA Vehicle appears to be damaged, defective, or in need of repair.

A copy of each WGA Vehicle Driver's license must be obtained for WGA insurance purposes and be presented to WGA and to any applicable rental car company. WGA reserves the right to require that a WGA Vehicle Driver provide (i) a letter from his/her doctor stating that the WGA Vehicle Driver has been in good health for at least 12 months, and/or (ii) a copy of the motor vehicle driving record from any state in which the WGA Vehicle Driver has held a driver's license in the past 5 years.

After submission of this WGA Vehicle Driver Agreement to WGA, a WGA Vehicle Driver must promptly
(and in any event prior to driving or agreeing to drive any WGA Vehicle) notify WGA in writing of any
accidents involving, or citations, tickets or warnings (other than parking tickets) issued to, the WGA
Vehicle Driver involving any type of vehicle, whether personal, rental, business or otherwise.

By signing and returning this WGA Vehicle Driver Agreement, I make the above representations, warranties and agreements. Without limiting the above, by designating myself as a "WGA Vehicle Driver," I, the undersigned, (1) agree that I will not be under the influence of or consume any alcohol, illegal drugs, or any prescription drugs that may impair my judgment prior to or during the time that I am driving the vehicle, (2) confirm that I drive on a regular basis (i.e., other than a WGA Vehicle) and am comfortable driving a passenger vehicle containing passengers. I agree to the terms set forth in this policy, and will hold WGA, its affiliates, employees, representatives and agents harmless from and against any claims, losses, damages, injuries, costs and expenses (including, without limitation, attorneys' fees and court costs) arising from the violation of this agreement. I permit WGA to obtain and examine my motor vehicle driving record, and will provide WGA with any additional documentation, consents and authorizations to permit WGA to obtain such record. I understand that WGA may terminate my authorization to drive a WGA Vehicle at any time, without or without a reason.
